This has a reference to your application No. 26/ SAS/ 2010-11 dated 12th July, 2010, for affiliation of a new Institute of Master of Management Studies (M.M.S.) degree course proposed to be started at, SAS Institute of Management Studies, Near Sakdham Complex, At. Saravali, Boisar, Dist. Thane- 401 501 for the academic year 2010-2011.

In this connection, I am directed to inform you that considering the permission granted by the All India Council for Technical Education, Higher & Technical Education Department, Government of Maharashtra and Director, Directorate of Technical Education, your Trust has been granted permission for first time affiliation to start a new Institute of Management imparting M.M.S. degree course with intake of 60 students in the name of SAS Institute of Management Studies, Boisar, Dist. Thane on 'Permanently No Grant Basis' from the academic year 2010-11, as per authorization given to the Vice-Chancellor by the Academic Council at its meeting held on 10th June, 2010, vide item No. 8.5, subject to pending the report of the Local Inquiry Committee to be appointed by the University and also fulfillment of terms and conditions mentioned in the aforesaid letters and give an undertaking in writing that they will fulfill the following conditions :-

1. That Institute will appoint the teaching and non-teaching staff as per the staffing pattern and pay their salaries as per the rules.
2. That Institute will follow the policy of reservation, as applicable, and as laid down by the Government of Maharashtra in respect of appointment of teaching and non-teaching staff and admission to the students.
3. That Institute will abide by the norms laid down by the University from time to time.
4. That Institute will charge the fees as approved by the Shikshan Shulk Samiti appointed by the Competent Authority, if any.

6. The College / Institute will follow the R.6064 mentioned in the Circular No. UG/83, dated 12th March, 2009.
7. That the minimum attendance of all the students must not be less than 75% during the academic year and College/ Institute will have to complete syllabus of all the subjects during the academic year.
8. Admission should not be linked with donation.
9. That they will strictly follow Ordinance 2802 in respect of preventing the Colleges/ Institute and Management of Colleges/ Institute from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No. Aff./Recog./49 of 1987, dated 4th February, 1987.
10. That they should follow the norms as prescribed and circulated by the University vide No. CONCOL/75 of 1988, dated 3rd March, 1988.
11. That College/ Institute shall not admit the students over and above sanctioned intake.
12. The College/ Institute shall appoint the teaching as well as non teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.


In case you could not start the College from the academic year 2010-11, the permission granted to your Trust will stands cancelled, which may please be noted.
